## **ANTI RAGGING COMMITTEE**

### **Regulation for Prevention & Control of Ragging**

Ragging in all form shall be completely banned in the institution and in all means of transportation of students whether public or private. The institute shall take strict action. The Regulation for Prevention & Control of Ragging is intended for prevention, elimination and control of the menace of ragging in all forms on the students of the institution whether within or outside its campus and to punish those who pamper in ragging.

### **Objectives of the Committee:**

The committee is assigned with the job of promoting the goals of the UGC Regulation and any other regulations put in place by the Governments of India to combat the scourge of ragging.

### **Functions of the Committee:**

- a. To prevent, prohibit, and address all types and incidences of ragging in the college.
- b. To educate the students on the meaning of ragging and what constitutes it. To teach students about the negative impacts of ragging and the legal penalties of engaging in ragging.
- c. Conduct awareness campaigns about the dangers of ragging, including its impact, consequences, and various redressal mechanisms.
- d. To investigate any reported cases of ragging and, if required, take appropriate action against the students who engaged in ragging.

### **Constitution of the Committee:**

The Anti Ragging Committee should be headed by the Director. The following members will be nominated by the Director for the tenure of one year.

- a. One representative of Civil Administration
- b. One representative of Police Administration
- c. One representative of Local Media
- d. One representative of NGO involved in Youth Affairs
- e. Two Parents representative
- f. Two student's representatives
- g. Two faculty members
- h. Two non-teaching staff



### **Duties & Responsibility of the Committee:**

1. The telephone numbers of the anti-ragging helpline and all-important functionaries shall widely be disseminated for access or to seek help in an emergency.
2. Any distress message received shall be informed to the head of the institution as well as the committee members immediately.
3. The Head of the institution shall be obliged immediately in response to the information received.
4. The committee shall maintain an appropriate database as a record of ragging complaints received and the status of action taken thereon.

### **Nature of Complaint:**

1. Every complaint by the student should be given in writing to the Director/ Committee.
2. The complaints in written format only would be considered for further actions.
3. Once the complaint is received the committee will discuss and handle the complaint within three working days.

### **Actions shall be taken by the committee**

1. The anti-ragging committee of the institution shall take an appropriate decision, regarding punishment
2. The Anti-Ragging committee may, depending on the nature and gravity of the guilt established award, one or more of the following punishments.
  - a. Suspension from attending classes and academic privileges (including field work & Research dissertation)
  - b. Withholding or withdrawing scholarships/ fellowships and other benefits.
  - c. Debarring from appearing the examination
  - d. Withholding the result.
  - e. Rusticating from the institution for a certain period
  - f. Cancellation of admission
